If at any time I have a change to my payment method, tuition schedule or decide to discontinue the automatic recurring payment plan, I will notify South Bay Dance Center in writing within two weeks of the new month. I also understand that if I were to add or drop classes that affect my tuition amount, I permit South Bay Dance Center to adjust my Automatic Recurring Payment on the beginning of a new month. If at any time my credit/debit card transaction is declined, I agree to provide South Bay Dance Center with another payment method and agree to pay the \$30 processing fee if payment is received after the tenth day of the month. I am aware of the studio policies, rules and payment schedules and agree to these terms.

I authorize South Bay Dance Center to automatically bill my credit/debit card **beginning January 1, 2024** for any costume deposits due. I also authorize South Bay Dance Center to bill my credit/debit card **beginning March 1, 2024** for any costume balances due. I understand that any applicable costume balances will continue to be deducted from my credit/debit card, as they become available, and until they have been paid in full.

If applicable, I authorize South Bay Dance Center to bill my credit/debit card for all South Bay Ballet Arts and/or Competition fees in monthly installments as stated in my contract.
