Continuing in 2023, serious ballet students at South Bay Dance Center may audition to become a part of **South Bay Ballet Arts**. This regional company is dedicated to the development of professional level dancers through high quality dance education and through professional performance opportunities. Following the tradition of the highest standards already present at South Bay Dance Center, **South Bay Ballet Arts** will provide an avenue for the most devoted ballet students while enriching the cultural life of the surrounding community.

South Bay Ballet Arts Performance Opportunities

- Company dancers may be split into classifications based upon level (soloist, senior or junior company member, apprentice).
- Company dancers will receive first consideration for all primary roles in The Nutcracker performances, when appropriate to level.
- Company dancers will present a featured piece and be part of an additional featured dance in SBDC' Showcase 2024.
- Company dancers may have additional performance opportunities throughout the season.

South Bay Ballet Arts Requirements

- All potential members must be dancing at SBDC's Ballet Level IIB and Pointe II (or at a comparable level).
- Auditions will be held during the pointe auditions for The Nutcracker August 19th and August 26^{tht}.
- Members must attend the South Bay Ballet Arts Company class weekly in addition to current level classes. Company class and rehearsals will begin in September, but the Company class may be used for rehearsal time.
- Members must meet SBDC's minimum ballet attendance requirements for the 2023 2024 school term session <u>in addition to</u> <u>attending SBBA company class</u>. Please be prepared to meet your requirements.
 - The minimum requirement for ballet students in level IIB is two classes a week at SBDC
 - The minimum requirement for ballet students in level III or higher is three classes a week at SBDC
 - Pointe II students must be attending two pointe classes a week at SBDC
 - Pointe III and IV students must be attending two pointe classes a week at SBDC. Students must also attend one non-pointe class taken entirely en pointe
- All company dancers must be participating in one additional genre of dance beyond ballet class.
- Three misses are allowed per required class per quarter (i.e. a company dancer may miss three of each required ballet class, three of each required pointe class, three company classes, three classes of their chosen genre from October to December, January to March, April to June). Make-ups will be accepted for technique classes only. Company class cannot be made-up as rehearsals will be taking place throughout the season. Members must meet these requirements to be eligible for performance.
- A company member not meeting rehearsal and/or class requirements may be dropped as a member of the company and/or from any portion of a performance without notice.
- The SBBA season runs from September to June; company dancers auditioning in August are committed through the 2024 Showcase. Students and parents will sign contracts to be turned in with the 1st installment payment agreeing to this season-long commitment. Members dropping their commitment mid-season may not be eligible to audition in future seasons.
- There is a \$575 **non-refundable** participation fee for all company members. The fee includes: The Nutcracker fees, rehearsal time for group pieces, Showcase 2024 featured pieces, rehearsal times and Company class time. Participation fees are due as an addition to your school-term tuition. The fee breakdown will be as follows: \$50 audition fee, \$325 due September 15th; the additional \$200 will be broken down into four monthly installments of \$50, due on the first of each month from January through April. A \$25 late fee will be assessed if participation fee is not paid by the tenth of the month (except for September). Participants who do not pay their fee by the 15th of the month will be asked to sit out of class and rehearsal. Missed classes or rehearsals due to unpaid fees will count as an unexcused absence.
